COMMITTEE'S UNDERTAKINGS IN THE PERIOD UNDER REVIEW

INTRODUCTION

Mr. Speaker Sir, the Sessional paper gives an account of the affairs of the Committee in the 5^{th} Session.

In the session under review, the Committee continued to execute its mandate of legislation, oversight and representation of the people while working in collaboration with a wide group of stakeholders to ensure participation in County Assembly processes and affairs as is required by law.

The policy framework, committee reports, statements, interrogations among other issues of concern to the committee and the publics were handled by the committee.

This report is therefore a summary of the activities of the committee in the fifth Session, 2021/22. The contents of this report were drawn from County Assembly trackers, committee minutes and reports.

SESSIONAL PERIOD

Mr. Speaker Sir, a "Session", according to the definition in the Standing Order means;

"the sittings of the County Assembly commencing when it first meets after a General Election or on a day provided for in Standing Order 24 (Regular Sessions of the County Assembly) and terminating when the County Assembly adjourns at the end of a calendar year or at the expiry of the term of County Assembly.

The Standing Order 24 on Regular Sessions of the County Assembly stipulates that;

(1) Except for the Session commencing immediately after a general election, the regular Sessions of the County Assembly shall commence on the second Tuesday of February and terminate on the first Thursday of December.

Mr. Speaker Sir, it should be noted that the 5th session of the second County Assembly however, resumed its sittings on 12th January, 2021 after the 2020 December recess and terminated its sittings on 17th February, 2022.

Allow me to skip 2.3 committee sittings I look at 2.5

COMMITTEE ACTIVITIES

Mr. Speaker Sir, during the session under review, the committee transacted the following activities:-

- 1. Successful internal committee meetings
- 2. Committee retreats.

Committee size and quorum

Mr. Speaker Sir, the current Committee membership as provided for in the Standing Order 11, this is similar to all standing Committees in the County Assembly of Bungoma.

The quorum for any standing Committee to hold its meeting therefore is a third of the members of the Committee, this includes the chairperson. This means that the committee requires a minimum of four (4) Honorable members to transact any business.

a) Committee Budget

Mr. Speaker Sir, the committee's budget for the year under review amounted to 5,295,941

b) Seminars and Training -Human Resource Audit

Mr. Speaker Sir, the Committee undertook training of Human Resource Audit between 28th to 31st January, 2021. The report on the training was tabled in the House and adopted with amendment.

c. Committee Retreats and Reports

During the year under review, the committee transacted the following businesses in line with its work plan and mandate.

i) NHIF, Gratuity and Ward operation

The Committee while carrying out its oversight role and following complaints by some Members of County Assembly retreated on 7th to 11th May, 2021 for the purpose of identifying the reasons behind the frequent suspension of NHIF and matters pertaining to gratuity and operations in the wards.

ii) Burial and Benevolent Status Report.

Mr. Speaker Sir, pursuant to the Constitution of the Burial and Benevolent Fund, the Committee of Welfare has the mandate of over sighting the Management Committee. The Committee retreated for the purpose of interrogating the financial report of the fund. The report prepared will be consumed during the Annual General Meeting of the Fund.

COMMITTEE'S OBSERVATION

- 1. That Committee meetings and activities as provided in the work plan were not achieved in totality due the Covid 19 pandemic and the tight retreat schedule provided by the Liaison Committee.
- 2. That the Management Committee of the Burial and Benevolent Fund had not held the annual General Meetings for its members since inception.
- 3. That the attendance of members to Committee internal and external meetings was timely and up-to-date in the session under review.
- 4. That there were delays in the remission of statutory deductions and in particular NHIF as the deadline is 9th of every subsequent month due to exchequer release delays.

5. That following the death of, Hon. Sitati Makhandia Daniel, MCA representing Khasoko Ward in the month of December, 2021, it was observed that the contribution from the Burial and Benevolent fund had no impact in the funeral arrangement. In the same constitution, the employers grant was provided but not specific on where the funds would be sourced from.

COMMITTEE'S RECOMMENDATION

Mr. Speaker Sir, the Committee hereby makes the following recommendations

- 1. THAT the remaining Committee activities provided in the work plan that were not achieved will be given priority in the next parliament
- **2.** THAT the Committee on Liaison should allocate adequate time and funds to Sectoral committees according to their mandate to enable them effectively execute their mandate.
- **3.** THAT the Committee has directed the Management Committee for Burial and Benevolent to organize for member's Annual General meeting before the end of March, 2022.
- **4.** THAT the County Assembly Service Board should prioritize payment of salaries on time in addressing the suspension of NHIF cover.
- 5. THAT the attendance of members to Committee internal and external meetings is recommendable.
- 6. THAT there is need to review the Bungoma Benevolent Funds' constitution to provide for direct contributions from the employer and increase the monthly contributions from members due to changes in economy.

We have the adoption schedule on page 10, the annexure on page 11 that is the approved schedule for internal committee meetings which is up to page 14.

I would like to request Hon. Wamusai who also appended his signature in this report to second.

Hon. Chrispinus Wamusai: Honourable Speaker. I am a devoted and committed member of Labour committee and allow me to appreciate my able Chair for moving the report so eloquently. I am on my feet to second the report and ask this House to approve the report with its recommendation.

The Bungoma County Appropriation Bill 2022. A bill by the County Assembly of Bungoma to authorize the issue of a sum of money out of the revenue fund and its application towards the service of the year ending 30th June, 2023 and to appropriate that sum and a sum voted on account by the County Assembly for certain public services and purposes - First reading.

Mr. Speaker: Honourable members, the Bungoma County Appropriation Bill 2020 having been read for the first time, it will be processed alongside the Bungoma County Annual Budget estimates for FY 2022/2023 accordingly.
