KEY HIGHLIGHTS DURING THE FIFTH SESSION

Mr. Speaker Sir, a "Session", according to the definition in the Standing Order means;

"the sittings of the County Assembly commencing when it first meets after a General Election or on a day provided for in Standing Order 24 (Regular Sessions of the County Assembly) and terminating when the County Assembly adjourns at the end of a calendar year or at the expiry of the term of County Assembly.

The Standing Order 24 on Regular Sessions of the County Assembly, stipulates that;

"Except for the Session commencing immediately after a general election, the regular Sessions of the County Assembly shall commence on the second Tuesday of February and terminate on the first Thursday of December."

Mr. Speaker Sir, it should be noted that the fifth session of the Second County Assembly however, resumed its sittings on 12th January,2021 after the 2020 December recess and terminated its sittings on 17th February, 2022.

Committee Internal Sittings

Mr. Speaker Sir, the committee held its regular meetings on Mondays from 3.00pm every week. These meetings were in line with the Liaison Committee internal meetings schedule prepared at the onset of the financial year 2020/2021 in July, 2020.

During the session under consideration, the committee held forty three (43) successful sittings out of the maximum fifty two (52) sittings as prescribed by SRC. It should be noted that committee meetings were interfered with due to Covid-19 restrictions for inter-person meetings, legislative conferences and conventions and public holidays. These sittings held considered a variety of issues including, adoption of committee reports, consideration of departmental expenditure reports, drafting committee work-plan, interrogations of various statutory documents, and investigations into matters resulting from referrals on the floor of the House.

Mr. Speaker Sir, from the table above, it was noted that the committee targeted to undertake an activity each month during the session; however, due to inadequate funding the committee could not implement all the activities as planned. During the session, the committee reviewed its work

plan to accommodate a handful of activities that could be implemented within the schedule as prepared by the Liaison Committee.

Committee Approved Budget

Mr. Speaker Sir, the committee was allocated **Kshs. 6,018,129** for the FY 2020/2021 and **Kshs 5,755,394** for the FY 2021/2022.

Challenges Faced during the session

Mr. Speaker Sir, during the period under consideration, the committee was faced with the following challenges:

- 1. The committee planned activities totaled to Kshs. 22,331,000; however due to inadequate funds, the activities had to be revised downwards to fit into the approved allocation.
- 2. The Liaison Committee schedule restricted the committee activities to a maximum of two activities per quarter in order to accommodate all the committees. This limited the implementation of the committee activities to the approved schedule.
- 3. Owing to the restrictions by the MOH due to the COVID-19 pandemic, inter-person meetings were restricted, thus derailing the implementation of some of the committee's planned activities.
- 4. Un-timely submission of documents by the Department. On a number of cases, the County Assembly requested for documents from the department for purposes of oversight which were often submitted late thus derailing the committee's oversight role.

CHAPTER THREE

COMMITTEE'S OBSERVATIONS AND RECOMMENDATIONS

Committee Observations

Mr. Speaker Sir, the committee made the following observations:

- 1. The Committee was not able to undertake all the activities on its work plan due to tight retreat schedule provided by the Liaison committee, inadequate funds and the Covid-19 pandemic constraints experienced in the year under review.
- **2.** The attendance of members to Committee internal and external meetings was timely and up-to-date in the session under review.
- **3.** The House made several adjustments to the County Assembly Calendar for the fifth session thus affecting implementation of planned activities of the committee.
- **4.** As at the time of production of this report, committee recommendations in a variety of Committee reports approved on the floor of the House were yet to be responded to nor implemented by the department.

Committee Recommendations

Mr. Speaker Sir, the Committee hereby makes the following recommendations:

- **1.** THAT the Committee on Liaison should allocate adequate time and funds to Sectoral committees according to their mandate to enable them execute their mandate effectively and in time.
- 2. THAT the committee on implementation should promptly follow up House resolutions and put departments to task to implement all House resolutions within the required timelines.
- 3. THAT there is need for enhanced joint seminars and consultative meetings with the executive on matters implementation and accountability for efficiency and effectiveness in execution of services to the public.
