CHAPTER TWO

Sessional period

Mr. Speaker Sir, a "Session", according to the definition in the Standing Order means;

"the sittings of the County Assembly commencing when it first meets after a General Election or on a day provided for in Standing Order 24 (Regular Sessions of the County Assembly) and terminating when the County Assembly adjourns at the end of a calendar year or at the expiry of the term of County Assembly.

The Standing Order 24 on Regular Sessions of the County Assembly stipulates that;

"Except for the Session commencing immediately after a general election, the regular Sessions of the County Assembly shall commence on the second Tuesday of February and terminate on the first Thursday of December."

It should be noted that the fifth session of the Second County Assembly however, resumed its sittings on 12th January, 2021 after the 2020 December recess and terminated its sittings on 17th February, 2022. This was due to the disruption caused by Covid-19 pandemic.

Objectives of the Report

The objectives of the sessional report training were to:

- 1. Assess the performance of the committee in line with its planned targets;
- 2. Enumerate the committee's achievements during the session;

3. Highlight the challenges faced by the committee in the course of implementation of its programmes

4. Recommend to the House the measures to be put in place to improve the committee performance in the subsequent session.

KEY HIGHLIGHTS DURING THE FIFTH SESSION

Introduction

The fifth session of the Second County Assembly commenced on 12th January 2021 and ended on 17th February 2022 as per the revised calendar adopted by the House during the sitting on 30th November, 2021.



The Committee on Justice and Legal Affairs prepared work plans for the financial year 2020/2021 and 2021/2022 which guided the committee in the achievement of its mandate as stipulated in the Bungoma County Assembly Standing Order 196(5).

In the session under consideration, the Committee continued to execute its mandate of legislation, oversight and representation of the people while working in with the departments at the County Executive.

This report is therefore a summary of the activities of the committee in the Fifth Session, 2021. The contents of this report were drawn from County Assembly trackers, committee minutes, reports and work plans.

Committee Internal Sittings

The committee holds its regular meetings on Thursdays from 11.00 a.m. every week. These meetings were in line with the Liaison Committee internal meetings schedule prepared at the commencement of the financial year 2020/2021 in July, 2020.

During the session under consideration, the committee held thirty eight (38) successful sittings out of the maximum fifty two (52) sittings; four sittings per month as prescribed by SRC. It should be noted that committee meetings were interfered with due to Covid-19 restrictions for inter-person meetings, legislative conferences and conventions and public holidays. These sittings held considered a variety of issues including; drafting and adopting committee work-plan, consideration of exiting legislations in the County, planning committee activities, interrogations of various statutory documents, adoption of committee reports and investigations into matters resulting from referrals on the floor of the house.

Attached is a copy of the Bungoma County Assembly Committee approved schedule for internal committee meetings for the fifth session that was followed in relation to committee meetings.

COMMITTEE WORKPLAN

The Committee on Justice and Legal Affairs was guided by the following work-plan in execution of its mandate of oversight, representation and legislation in the County Assembly of Bungoma in the session under review. This work plan was tabled in the House therefore, I will not go through.

Committee Approved Budget

The committee was allocated Kshs. 5,295,941 for the FY 2020/2021 and Kshs 5,095,400 for the FY 2021/2022. As at 31st December, 2020, the Committee had spent Kshs. 1,633,200

Committee reports

The Committee managed to the following reports that were as the result of retreats that the Committee undertook, presented and adopted in this Honorable House in the session under review.

- Ø Public participation and report on the Constitutional Amendment Bill, 2020

Committee Achievements

The committee accomplished the following activities during the period under review:

Ø The Committee invited the public and stakeholders to the public participation exercise on the constitutional Amendment Bill, 2020 pursuant to Article 196 of the Constitution.

 \emptyset Through the capacity building exercise, members understood their mandate and hence were able to exercise their constitutional and statutory mandates.

 \emptyset From the report on the pending law suits, the committee informed the House on all the pending law suits, their nature and the budgetary implications.

 \emptyset The Committee recommended the fast tracking of the enactment of the subsidiary legislation pursuant to Acts passed by this House.

Challenges faced during the session

The committee was faced with the following challenges during the period under consideration:

1. The committee planned activities totaled to Kshs. 15,044,950; however due to inadequate funds, the activities had to be revised downwards to fit into the approved allocation.

2. The Liaison Committee schedule restricted the committee activities to a maximum of two activities per quarter in order to accommodate all the committees. This limited the implementation of the committee activities to the approved schedule.

3. Owing to the restrictions by the MOH due to the COVID-19 pandemic, inter-person meetings were restricted, thus derailing the implementation of some of the committee's planned activities.

CHAPTER THREE

COMMITTEE OBSERVATIONS AND RECCOMMENTATIONS

Committee Observations

The committee made the following observations;

1. The Committee mandate as per the Standing Order was not clear hence different interpretations resulting to ineffective execution of the mandate.

2. The Committee was not able to undertake all the activities on its work plan due to tight retreat schedule provided by the Liaison committee, inadequate funds and the Covid-19 pandemic constraints experienced in the year under review.

3. The attendance of members to Committee internal and external meetings was timely and up-to-date in the session under review.

4. The House made several adjustments to the County Assembly Calendar for the fifth session thus affecting implementation of planned activities of the committee.

5. The Committee noted delayed publication of the Bungoma County Enforcement of Social Economic Right Bill, 2020. (Dignity Bill)

Committee Recommendations

The Committee hereby makes the following recommendations:

1. THAT, all Members of the County Assembly should be sensitized on the mandates of all Committees at the beginning of every new County Assembly to enrich their oversight role.

2. THAT, the Committee on Liaison should allocate adequate time and funds to Sectoral committees according to their mandate to enable them execute their mandate effectively and in time.

3. THAT, the Committee on Implementation should promptly follow up House resolutions and put departments to task to implement all House resolutions within the required timelines.

4. THAT, the Office of the Clerk should fast track the publication of Bills to enhance the legislative role of the County Assembly (Bungoma County Enforcement of Social Economic Right Bill, 2020. (Dignity Bill)

That marks the end of the report. We have the adoption schedule attached to the report where members have signed.
