MOTION

REPORT BY THE POWERS AND PRIVILEGES COMMITTEE IN RESPECT TO THE EVALUATION OF THE COMMITTEE'S PERFORMANCE OF THE SECOND COUNTY ASSEMBLY

(Resumption of Debate)

Mr. Temporary Speaker: Honourable members this is resumption of a motion that we had in the morning, I propose the same for debate;

Hon. Sudi Busolo: *(On a point of information)* Mr. Speaker, the mover of the motion is not in the House. He is not the one who moved the motion, unless we have changed the rules. The motion was moved by Hon. Paul wamalwa, now, a person who did not move the motion cannot stand here and pretend that he is going to reply to the motion. I need to be corrected Mr. Speaker. The motion was moved by the Hon. Wamalwa and now another member of the committee is purporting to stand in for Hon. Wamalwa. I have never seen this happen!

Mr. Temporary Speaker: Noted Hon. Sudi.

Hon. Jack Wambulwa: Mr. Speaker, I want to second Hon. Sudi that we cannot have a mover of the motion absent then another new person comes to step in. Is he or she aware of what transpired in the morning session? Thank you Mr. Speaker.

Hon. Rosemary Khisa: Thank you, Hon. Speaker. As I support the sentiments raised by Hon. Sudi and Wambulwa, I seek to know this argument is based on which Standing Order through the Speaker.

Hon. Winnie Nyambok: Thank you, Hon. Speaker. Hon. Paul has told me that he is on the way coming. I was going to note down the concerns of members as we carry on with debate. Looking at the mood of the House, I don't see any intention for debate and there is no conspiracy theory. May be you just put the question Hon. Speaker. Thank you.

Mr. Temporary Speaker: Let me get you clearly Hon. Nyambok.

Hon. Winnie Nyambok: The Hon. Paul is on the way coming, he had requested me to take note of the issues being raised and by the time he arrives, I could have responded. Looking at the mood of the House, there is no conspiracy theory. Members are free to raise their concerns if any and by the time we finish Hon. Paul will be here. Looking at the mood, I don't see anyone who wants to debate. Kindly put the question so that we move on.

Mr. Temporary Speaker: Point noted!

MOTION OF ADJOURNMENT PURSUANT TO STANDING ORDER 49 (B)

Hon. Chrispinus Wamusai: Thank you, Hon. Speaker. Under Standing Order 49 (b) motion for adjournment of a county assembly or of debate; the law is clear and on matters legislation this being a House of debate, rules and procedures, there is no short cut. On that basis; on the premise that the mover of the motion is not present, we cannot kill the motion. Under this Standing Order I seek to move a motion of adjournment under Standing Order 49 (b). On this basis I request Hon. Sudi Busolo member for South Bukusu to second the motion. Thank you Hon. Speaker.

Mr. Temporary Speaker: Hon. Wamusai, we adjourn to when?

Hon. Chrispinus Wamusai: We adjourn to tomorrow at 2:30 p.m. Thank you Hon. Speaker.

Hon. Rosemary Khisa: I have concern; today's business is not about Bumula alone. You are the chairperson from Bumula...

(Laughter)

Mr. Temporary Speaker: Point noted, Hon. Rosemary! It shows how active people from Bumula are. Hon. Sudi.

Hon. Sudi Busolo: Mr. Speaker, I second the motion. As I had earlier stated that there is no single day for the last four and a half years we have been here that when a mover of the motion is not present another person steps in. Let us adjourn and deal with this motion tomorrow at 2:30 p.m.

Mr. Temporary Speaker: A motion to adjourn the motion having been moved and seconded, I direct that the motion be debated tomorrow at 2:30 p.m.
