QUESTIONS AND STATEMENTS

STATEMENT PURSUANT TO STANDING ORDER 47 (2) (A)

Hon. Anthony Luseneka: (On a Point of Information) Thank you, Hon. Speaker. I am just wondering as we are sited here, we have almost 4 methods of signing in this plenary. I am seeing this biometric, we have the cards, a register, Sergeant-At-Arms are also ticking our names as if we are in a military camp, CCTVs are there, so I am wondering if we cannot trust one system, our own system, who else could trust us? We are very keen on making sure that we are captured on all the lists, missing the point on why we are here, some of us are just here because we want to sign in. If you can give direction on that, which method is authentic because when you forget

your card at home they say that... I need your protection, so if you can give us direction on the best method to make sure that I am present today in this Assembly.

Temporary Speaker: Thank you, Leader of Minority. Before I respond I can see Hon. Jackson Wambulwa is online, let's allow him.

Hon. Jackson Wambulwa: Thank you, Hon. Speaker. I want to second what the Leader of Minority has raised. As you are aware starting from the entrance you have to finger in...

(Laughter)

Yes you have to finger in...

Temporary Speaker: Hon. Jackson Wambulwa, please explain we need to understand what you mean by fingering in.

Hon. Jackson Wambulwa: Hon. Speaker, fingering and keying in is one and the same. Coming inside you have to enter your card, as you enter your card the Seargent is standing trying to tick who is present and who is not present. After that they are bringing another kit you have again to key in; surely how many times are we going to do this. CCTV is there monitoring who is in this House, your own computer as you are sited you already know who are this House. I think it is becoming unbearable. We request the leadership where the Leader of Minority is to sit down and discuss and have a way forward.

There are Counties that have no gadgets at all; do you want to tell me these counties cannot be paid because of that? Not all Counties have gadgets, for us at least we have tried and we are ahead. Why should it be an audit query to Bungoma and other Counties are not being audited over the same?

We have major fraud cases out there that are happening. Why should they target these poor Members of County Assemblies whom even the government does not want to recognize when it comes to increasing their pension? They are always out there to monitor us on how we are moving, whereas coming for these chamber sittings we are not being paid anything. Why should we be monitored left and right? We are not being paid so it is time as a House we make a stand but before we make that stand, I want to request the leadership to sit down and discuss, and have a solution to this. If it will be the card then let it be that and not this many ways, it must be either one or two but not too many things that make members feel unsafe.

Temporary Speaker: Thank you, Hon. Jack Wambulwa for the concerns. I will give 2 minutes to Hon. Everton Nganga,

Hon. Everton Nganga: Thank you, Hon. Speaker for giving me a chance to contribute on what Honourable Leader of Minority has raised. This is a changing world and the systems that are being introduced are here to make sure that Members are never surcharged anymore because

there are so many audit queries that are always raised by the Auditor General. To my understanding, in accounting when I am reconciling a bank reconciliation statement and the cash book that is found in the business of the owner, I look at the items that are appearing in the bank statement and the cash book of the business so that at the end of everything, I will discover those that were appearing in both and those that were not appearing in both then I will make my conclusion.

I am for the system, let it exist and nobody should be worried, you are elected to come here and ventilate on issues oversight, we have to be here. If we are not doing anything bad why are you worried?

(Applause)

Hon. Francis Chemion: Hon. Speaker, I will not take two minutes. I just want to take one minute. Something that has come up and is recorded on HANSARD is fingering in and if you look at what it means in the dictionary... I want you to ask that it is deleted from our records, because we members don't finger in. You can declare that bit.

Temporary Speaker: Thank you, Hon. Masai Chemion. I want to call upon the Honourable member who used the word to do the necessary.

Hon. Jack Wambulwa: Hon. Speaker, unless Hon. Chemion did not get my correction because I ended up telling the House it is keying in, so fingering and keying in is more or less one and the same; using a finger. When you use a finger, you enter into a hole what do you say?

Temporary Speaker: Okay members, I think because we have other businesses to conduct in the House I will give Hon. Job to be the final member to contribute on this issue then I will give my direction.

Hon. Job Mukoyandali: Thank you, Mr. Speaker for giving me this chance. I concur with what majority of the members have said, we need to make a link so that all these systems are working in unison so that it doesn't look like we are being monitored as if we are criminals. We have come here to represent people and I am sure that no member will just miss to come here, so let them link these systems to become one so that the work is easy.

Secondly, there are so many notable changes happening within our area of work especially when I talk about our committees and every day we are being informed of changes, like recently I was informed that if you go to Kisumu, you will not be given transport reimbursement. I don't know if this applies to Bungoma only or other counties. I don't know if we are working within the budget or outside the budget. Therefore, many things are coming up and if there is any advisory maybe coming from the Controller of Budget then we are supposed to do something. It should be tabled in the House so that all members are aware of what is happening instead of things happening without our knowledge.

(Applause)

Hon. Hentry Nyongesa: Mr. Speaker, I have listened to the Leader of Minority...

Hon. Hentry Nyongesa: Yes Mr. Speaker. That the Leader of Minority has raised a motion within a motion but I am thinking loudly that decisions are trickling up-down and the Leader of Minority is in leadership in this House. The leader was raising a query that what we are monitoring is becoming much. But the information trickles from up-down, therefore, I think the leader was testing our capability if we can argue on the same but he has the information. Hence, I concur with Hon. Jack that he has the answer and in the next sitting the Leader of Minority will give us the answer on the same.

Temporary Speaker (Hon. Benjamin Otsiula): That is a presumption that the Leader of Minority has information. Members I want to appreciate you for your concerns. I have already directed Hon. Ipara and therefore just persevere. I appreciate the concerns made by honourable Members in this House concerning the issue at hand. We have the biometric register, we also have the cards and you also key in as you come in. However, this is an issue that has already been raised by a host of the honourable members here and the issue is now with the Liaison Committee and the House Leadership. It is going to form the basis of consideration as this committee is expected to retreat from today evening for a report writing exercise. I kindly call upon honourable members to be patient so that after those deliberations an official communication will be made in this House. We now proceed with the order of business as per the order Paper.

Guiding principles on the examination of the County Government Quarterly report and financial statements

In the execution of the mandate the Committee on Labour Relations, Members Services and facilities is given the legal backing under the Constitution of Kenya 2010, Public Finance Management Act 2012, and County Government Act 2012.

These statutory provisions include;

i) Constitutional Principles and Public Finance

Article 21 of the Constitution of Kenya 210 enacts fundamental principles that shall guide all the aspects of public finance in the republic. These principles include;

(a) There shall be openness and accountability including public participation in financial matters, 201 (d) public money shall be used in prudent and responsible way and 201(c) financial management shall be responsible and fiscal reporting shall be clear.

Section 149(1)(a)(b) of the PFMA, 2012 provides as follows; the accounting officer is accountable to the County Assembly for ensuring the resources of the entity for which the officer is designated are used in a way that is;

- (a) Lawful and authorized
- (b) Effective, efficient, economical and transparent

ii) Direct personal liability

Article 22(5) of the Constitution of Kenya 2010 is emphatic that "If the holder of a public office, including a political office, directs or approves the use of public funds contrary to law or instructions, the person is liable for any loss arising from that use and shall make good the loss, whether the person remains the holder of the office or not".

Obligations of Accounting Officers

The Public Finance Management Act, 2012 section 166 states as follows;

- 1. An accounting officer for a county government entity shall prepare a report for each quarter of the Financial Year in respect of the entity.
- 2. In preparing a quarterly report for a county government entity, the accounting officer shall ensure that the report—
 (a) contains information on the financial and nonfinancial performance of the entity; and
 - (b) is in a form determined by the Accounting Standards Board.
- 3. Not later, than fifteen days after the end of each quarter, the accounting officer shall submit the quarterly report to the County Treasury.
- 4. Not later than one month after the end of each quarter, the County Treasury shall—
 (a) consolidate the quarterly reports and submit them to the county assembly;
 (b) deliver copies to the Controller of Budget, National Treasury and the Commission on

Key Highlights on the 4th Quarter Financial Statement for the Financial Year 2022/2023The county targeted revenue projection for the financial year 2022/23 was **Kshs. 14, 824, 738, 618** as per the approved 2nd supplementary budget. Below is the breakdown of the sources of revenue;

The County Public Service Board

The County Public Service Board operated on a recurrent budget of 54,046,205 and a total development budget of Kshs. 10,000,000.

Revenue

The Board does not collect any revenue and AIA. A total of Ksh 45,587,411 was realized as exchequer based on the requests the Board had submitted. From the amounts received, 42,182,040 towards recurrent and Kshs. 3,405,371 was towards development.

Expenditure

Kshs. 6,713,128 was spent on staff salaries which represents 96% of the allocation towards the same.

Budget Execution by Programmes and Sub-Programmes

During the period under review, the Board anticipated only one project- Construction of the Office Block at a provisional figure of Ksh. 10,000,000. Out of the Budgeted amount, Kshs. 3,405,371 was paid to the Consultancy firm contracted to engage in developing BQs and building plans for the office in the year 2015.

Allocation of land has been an issue but currently, CECM Lands have awarded space next to the Labour Office and the contractor is set to begin works but currently just for correction, the project is ongoing and is behind Teacher's plaza. The site changed from labor offices to teacher's plaza

Accounts Payable

At the beginning of the FY 2022/23, a total of Kshs. 9,049,181 was due to the suppliers. As at 303th June 2023, the Board had paid a total of 8,149,181 had been paid leaving a balance of Kshs. 900,000 only owed to Joventure Hotel Kisumu. The amount has since been declared and shall be considered in the current Financial Year.

Supplier of credit vote had an allocation of Kshs. 6,603,181 on recurrent out of which Kshs. 2,623,600 recurrent pending bills was paid.

Development pending bill pay out was done on the allocation for construction of administration block to pay BQs and Plans for the administration block presenting misapplication of funds.

Accounts Receivable

The Board had outstanding imprests totalling to Kshs. 5,357,395 as at the 30th June 2023. The County Public Service Board had cleared and had no unsurrendered imprests to report on as at the time of interrogation.

The County Assembly Service Board

Revenue

The County Assembly relies on exchequer release as source of revenue. In the year under review, it had a total budget of ksh.1, 294,353,579 comprising of development ksh.106, 793,185 and recurrent ksh.1, 187,560,394. The transfers from exchequer amounted to 1,256,268,326

representing 97% release i.e. Ksh.1, 187,556,988 for recurrent representing a near 100% release while development ksh.68, 711,338 representing 64% release.

Expenditure

The Assembly had an annual Expenditure of Kshs. 1,245,449,346 which relates to 96% absorption comprising of Kshs.1, 176,738,008 recurrent expenditure and Kshs. 68,711,338 for Development expenditure.

Recurrent Expenditure Analysis

The total recurrent expenditure of Kshs. 1,176,738,008 as detailed below:

Budget Execution by Programmes and Sub-Programmes

Acquisition of Assets amounted to represented as Ksh 68, 711,338 representing 64% absorption County Assembly had an approved budget of Kshs. 106,793,185 for development. It was expended as follows;

- New administration block Ksh 62,451,513
- Pending bills for teammate audit system Kshs. 3, 550,418. 57.
- ➤ Hansard system Ksh 2,709,406.30

Accounts Payable

Accounts receivables (outstanding Imprests) across all departments amounted to Kshs. 13,788,064 compared to Kshs. 2,970,000 same period in the previous FY. Legislative services department has the highest outstanding imprests at Kshs. 3,768,500 followed by Committee Services department at Ksh. 3,018,200. The department with least outstanding imprests is Administration at Ksh. 40,000. As at the time of interrogation, the departments had cleared all the imprests.

General Committee Observations and Recommendations

Committee General Observations.

The Committee made the following observations.

- 1. The County Public Service Board has Land allocated to it and is set to begin construction of the office block.
- 2. The County Public Service Board had a total pending bill of Kshs. 900,000 as at 30th June 2023.
- 3. Under development expenditure, the County Public Service Board spent Kshs. 3,405,371 on coming up with the BQs for the Administration Block dating back to the year 2015.
- 4. The two Boards had no un-surrendered imprests to report on.

Committee Recommendations

The following recommendations were made by the Committee:

1. That, the County Public Service Board should declare and prioritize the payment of pending bills when preparing proposed budget estimates to avoid unnecessary litigation and accumulation.

- 2. That, the County Public Service Board should see to it that the construction of the Administration Block on the land allotted to them by the County Government before the lapse of the Financial Year.
- 3. That, County treasury should ensure the correctness of the financial statements by consulting the user departments.
- 4. That, Imprests should be managed according to the Public Finance Management laws that states: PFM reg, 93(5) A holder of a temporary imprest shall account or surrender the imprest within seven (7) working days after returning to duty station.
- 5. That, the approved budgets should be implemented pursuant to PFMA 149 (1).
- (1) An accounting officer is accountable to the county assembly for ensuring that the resources of the entity for which the officer is designated are used in a way that is—
- (a) Lawful and authorized; and
 - (b) Effective, efficient, economical and transparent.

That is the end of our report and the report was duly adopted by every member signed against the report and as agreed, that's a correct report.

Mr. Temporary Speaker: Thank you Hon. Henry Nyongesa for moving the motion.

Hon. Henry Nyongesa: I think the last page is the minutes of the committee that are approved by the same. So thank you, Mr. Speaker I want to request that Hon. Caleb Wanjala seconds the report.

Mr. Temporary Speaker: Thank you, Hon. Henry Nyongesa. Hon. Caleb Wanjala proceed

Hon. Caleb Wanjala: Thank you, Mr. Speaker. I rise to second the report.

(Applause)

Mr. Temporary Speaker: Thank you Hon. Caleb Wanjala for your brief seconding remarks.

Hon. Members, a motion on the report by the Sectoral Committee on Labour Relations, Members Service and Facilities on the Bungoma County Government fourth quarter financial statements for the period ended 30th June, 2023. Arising from that, let the Sectoral Committees be given the time to handle what is in line with the budget lines.

I want to request that that the Sector Committees be given those powers and their recommendation should remain within the Sector Committees such that as the House will be approving what was emanating from the executive towards the Sector Committees, will be a picture and the recommendations of the Sector Committees. I support the motion.

Mr. Temporary Speaker: Thank you Hon. Henry Nyongesa for your contribution. Hon. Millie Masungo.

(Loud Consultations)

Hon. Millie Masungo: Thank you, Mr. Speaker. I don't know why Hon. Members are looking at me seconding our motion does not restrict me from contributing on the same motion. Thank you very much to have given me this chance. Mine is just to insist that we are going to interrogate a budget, our annual budget with Executive and Sector Committees.

Mr. Temporary Speaker: Yes, Hon. Ali Machani, what is the point of information?

Hon. Millie Masungo: Mr. Speaker, I don't want to be informed.

(Loud consultations)

Hon. Ali Machani: Mr. Speaker, is it in order for a member to contribute twice to the same motion? She was given a chance to second the motion and had enough time to contribute. Is it in order for her again to come the second time on the floor on the same motion?

(Laughter)

Mr. Temporary Speaker: Thank you, Hon. Ali Machani. Hon. Millie Masungo requested to contribute, I thought she was going to rise on a point of information but being the seconder, I think she had her chance to make all pronouncements and I therefore sustain the point of information. Debate having ensued, I therefore call the mover of the motion to respond.

Hon. Joseph Nyongesa: Thank you, Mr. Speaker. First, let me appreciate members for the overwhelming support on alteration of Tuesday to Wednesday and Members what Hon. Nyongesa was saying is very key and also call upon Honourable Chairs and Committee Members on Sectoral Committees, that actually it is a programme or setting the ceilings of every department. Otherwise, I appreciate the support from the House and wish you all the best as you interrogate all programmes of sectors.
