CHAPTER ONE

Preface

The report provides information on the Business transacted by the County Assembly covering the period commencing 14th February to 7th December, 2023. The focus is on consideration of Bills, Papers laid and Notices of Motion issued Motions, Petitions, Statements and/or Questions. During the period, the House did play its role in Legislation, Representation and Oversight as provided in Article 185 of the Constitution. Great impact was particularly realized through adoption of reports on various issues, consideration of Petitions from the public on various issues of concern, passage of Bills, vetting of nominees to public offices with the aim of ensuring sound leadership in the management and running of public affairs and seeking responses from the County Executive Committee Members through Statements and/or Questions.

The House was also involved in analysis and passage of the Second Supplementary budget FY 2022/2023 the Annual Budget FY 2023/2024 and the first supplementary budget FY 2023/2024 Further, the House continued to engage the public in its affairs through a variety of avenues as per the provisions of the Constitution. The actualization of the Committees' activities as highlighted in the work plans were also a great success. These activities encompassed weekly Committee sittings, inquiries and all activities which were carried out either within or outside the Precincts of the County Assembly.

CHAPTER TWO

Introduction

Resumption of the House

The second Session of the third Assembly began on Tuesday, 14th February, 2023 and ended on Thursday 7th December, 2023. This Report, therefore, provides information on the legislative and other Business transacted in the County Assembly during this period.

The very first business that was to be transacted by the House at the commencement of the session was the establishment of the House Business Committee as provided for in Standing Order 173 (1) (g) and approval of the Calendar of the Session.

On Tuesday, 14th February, 2023 the House approved the House Business Committee and approved the Calendar of the House (Regular Sessions) for the second Session 2023 pursuant to Standing Order No. 31 with an anticipation of one hundred and twelve (112) Sittings between January 14th and December 7th. There were short periods of recess to allow members undertake other activities. However, during the period under review, the House altered its Calendar and adjournment dates on two occasions as follows:

- i. On 22nd June, 2023 three weeks before the short recess, it adjourned as per the resolutions of the County Assemblies consultative meeting held on 17th June, 2023 at Safari Park Hotel, Nairobi.
- ii. On 7th September, 2023 to allow the House sit for two weeks during the long recess and handle urgent Business of the House.

By the end of the Session, the County Assembly had held a total of ninety five (95) Sittings; of these Sittings, one (1) was a Special Sitting.

Observation

During the period under review, the House lost seventeen Sittings (17) due to the adjournment Motion.

Special Sitting

A special sitting is a sitting held by the House on a day other than a day prescribed in the regular calendar of the House. The House may hold a special sitting upon request by the Leader of Majority Party or coalition parties or the Leader of Minority Party or coalition of parties with the approval of the Speaker.

A special sitting may also be convened if any group of members not being less than one third of the total membership of the House address a letter to the Speaker with their names and signatures appended on the later requesting that the House be convened while it is on recess .During the Session the House held a Special Sitting on Thursday 7th September, 2023 convened vide Gazette Notice No. 11827 dated 5th September, 2023 for the purpose of altering the Calendar of the House (Regular Sessions) 2023.

Visit and address by H.E. the Governor

Section 30 (2) (k) of the County Governments Act, 2012 and the County Assembly of Bungoma Standing Order 26 (1) provide that the County Governor shall deliver an annual state of the County address containing such matters as may be specified in County legislation. In line with the aforementioned, H.E. the Governor delivered the second address to the County Assembly on Tuesday, 21st February, 2023.

County Assembly House proceedings and business

Communication from the Chair

The Speaker of a parliamentary body plays a crucial role in maintaining order and facilitating communication within the legislative assembly. Here are some common observations about parliamentary communications made by the Speaker:

Maintaining decorum: The Speaker often reminds members of the parliament to maintain decorum and adhere to parliamentary rules and procedures during debates and discussions.

Time management: The Speaker manages the allocation of time for different agenda items, ensuring that each topic or bill is discussed within its allotted time frame.

Recognition of members: The Speaker recognizes members who wish to speak, ensuring that they follow the established protocol for seeking the floor.

Enforcing rules of debate: The Speaker ensures that parliamentary debates are conducted in an orderly manner, enforcing rules related to speaking time limits, relevance of speeches and decorum.

Maintaining impartiality: The Speaker is expected to remain impartial and not take sides in debates, ensuring that all members have an equal opportunity to express their views.

Resolving disputes: In the event of disputes or disagreements among members, the Speaker may step in to mediate and find a resolution in accordance with parliamentary rules.

Decision on points of order: The Speaker decides on points of order raised by members, determining whether parliamentary rules have been violated and taking appropriate action.

Announcements: The Speaker may make announcements regarding the parliamentary schedule, voting procedures, or any other important matters.

Calling for votes: When necessary, the Speaker calls for votes on bills or motions, ensuring that the voting process is conducted accurately and transparently.

Closing sessions: The Speaker formally adjourns parliamentary sessions, marking the end of the day's proceedings. These observations highlight the essential role of the Speaker in facilitating effective communication and maintaining order within a parliamentary assembly.

It is the prerogative of the Hon. Speaker to guide the House in its proceedings and decision making by invoking the Standing Orders. Apart from the rules of the House as encompassed in the Standing Orders, the Speaker may guide the House by way of "Communications from the Chair".

During the period under review, a total of forty six (46) Communications were issued. The Communications encompassed considered ruling on procedural questions, information to the House, guidance to the House, convocation of Special Sittings, business of Committees, invitation of members to conferences, political parties, affairs and recognition of visiting delegations among others.

Messages from H.E the Governor

Pursuant to Standing Order 45, the House received and processed six Messages from H.E the Governor with regard to nomination of persons for appointment to the positions of County

Executive Committee Member, Chief Officers, Members of the Kimilili and Bungoma Municipalities, member of the County Public Service Board and County Secretary and Head of County Public Service.

Public Petitions

Petitions are written prayers made to the House under Articles 37 or 119 of the Constitution by a member of the public requesting the House to consider any matter within its authority. The provisions of Article 37 of the Constitution and Section 15 of the County Governments Act, 2012 state that a person has a right to petition a County Assembly to consider any matter within its authority, including enacting, amending or repealing any of its legislation. Every Petition presented pursuant to Section 15 of the County Government's Act, 2012 stands committed to the Committee on Justice and Legal Affairs for consideration within sixty (60) calendar days.

During the Session, the House processed three (3) Petitions.

- i. Petition on the denial of right to health services to Johnkin Wanjala and his subsequent death at Webuye County Hospital
- ii. Petition on the new organogram in the Department of Health and Sanitation
- iii. Petition in reference to market construction for mobile traders at Dinah flyover

Two other Petitions were still before the relevant Committee for processing. These were:

- i. Petition on the need to assist allocate land and resettle the Cave dwellers.
- ii. Petition in reference to poor management of the new Chesikaki farmers' Co-operative Society and illegality of the current office bearers

Compliance with statutory timelines for petition processing, as outlined in relevant laws and regulations, is crucial to ensure accountability, enhanced responsiveness of County Assemblies, demonstrates commitment to serving the needs and concerns of the constituents and fosters public trust and engagement in the democratic process.

Papers laid

During the period under review, a total of one hundred and sixty three (163) Papers were tabled in the House. They included one hundred (100) Committee reports, eighteen (18) reports from the Office of the Auditor General and twenty eight (28) reports from the County Executive, two (2) Regulations, eight (8) Policies/guidelines and four (4) reports from the County Assembly Service Board.

This was on 6th June, 2023 to discuss the prioritization of the release of bursary allocation of Kshs4, 000,000 to the forty-five (45) Wards.

Statements and Questions

Statements and questions play crucial roles in parliamentary proceedings:

Statements

Statements allow government officials or Members of Parliament to provide important information to their colleagues and the public, enhance accountability and ensure transparency.

Ouestions

Questions promote scrutiny, accountability and information gathering as they serve as a mechanism to scrutinize government actions and policies. They can reveal potential issues or inconsistencies.

During the period under review, Members employed use of Statements and/or Questions to bring various matters before the House. There were 70 Statements/Questions, out of which 47 Statements were directed to the respective County Executive Committee Members and Chairperson of various Sector Committees, 22 statements were pursuant to the provision of Standing Order 47 (2) (c) informing the House of the Business coming before it during the following week and one personal Statement from Hon. George Tendet thanking all Members who supported him when he had an election petition.

Bills

Article 185 of the Constitution of Kenya, 2010 provides that the legislative authority of a County is vested in and exercised by its County Assembly.

The Public Finance Management (Bungoma County Executive Employees' Car loan and Mortgage Scheme Fund) Regulations, 2023 is still under consideration by the Committee on Delegated County Legislation.

1. Review of parliamentary activities is important for accountability, transparency, oversight, legislative improvement, public engagement, historical records and for upholding democratic values.

Hon. Speaker, this report has been adopted by all the members of the Committee. Allow me to call upon our Leader of the Majority, Hon. Joseph Nyongesa Juma, to second the same report.

Hon. Joseph Nyongesa: First, allow me to appreciate the Deputy Speaker for taking us through the review report of the last session. Mr. Speaker, as we are aware, this report is self-explanatory and because members were keen and they have seen the work during the session under review; it clearly indicates that this House has done a lot of work.

Secondly, just a word of encouragement on statements where three did not give satisfactory responses to this House; it is an indicator of some weakness in those departments. As we said before, the Implementation Committee should always follow up to make sure that whatever is approved in this House is implemented.

Lastly, we also appreciate all members for being focused on their legislation mandate. I support and second.
