They have seen how we work and operate. And when we had bursary Syoya Secondary School has been getting its bursary from my Ward. I have students from Kibachenche, Lumboka who goes to St Jude Syoya Secondary School. All I can say is just wish them well so that as we retire they come and take over because this House is not just a unique House for a few but if they work hard in school, then one or two of them may come here because you cannot be two, Kabula Ward needs only one MCA.

Syoya is where my parents were born because we migrated from Kabula to Mateka, and I want to thank their parents for voting for Hon. Vitalis and I know that he is worried that if I contest in Kabula then I have a huge population there of about 40 per cent.

When they go home, let them tell their parents what Sudi has said, the name Sudi is a household name in Kabula that we vote for Hon. Vitalis again. We are working together. Hon. ## PREFACE

Pursuant to the provisions of Standing Order No. 205, all the reports of the Sectoral Committee of Gender, Culture and Social Welfare adopted by the House were conveyed to the CECM for Gender, Culture, Youth and Sports. The CECM is required, within 60 days to submit a report to the Committee in accordance with Article 183 (3) of the Constitution.

However, the CECM has never reported on the implementation status of the committee resolutions adopted by the House. As a result, the Committee interrogated the department on the implementation status of the Committee resolutions considered by the House in the year 2022 and 2023.

During the period under review; the following reports and legislations considered by the Sectoral Committee on Gender, Culture and Social Welfare were adopted by the House and conveyed to the CECM Gender, Culture, Youth and Sports;

- i. Report on the status of Gender Based Violence cases in Bungoma County

- iii. Report on Assessment of Application of laws guiding the implementation of programs by the department of Gender and Culture adopted on 1st November, 2022
- iv. The Bungoma County Alcoholic Drinks Control Act, 2015
- v. The Bungoma County Cultural Heritage Act, 2023
- vi. The Bungoma County Public Entertainment Act, 2023

On 12<sup>th</sup> May, 2025, the Committee held a consultative meeting with the department of Gender and Culture to examine the implementation status of the three reports and three legislations that had been considered by the House in 2023 in respect to the department

**The following are the House resolutions for each of the aforementioned reports, departmental response and committee observation.**

### **Report on the status of Gender Based Violence cases in Bungoma County**

#### **Resolution 1**

**THAT**, the County department of Gender to ensure adequate budgetary allocations in subsequent budget cycle FY 2023/24 for the implementation of GBV interventions. This will invest in leveraging partnerships with the private sector to enhance their corporate social responsibility, NGOs and CBOs to strengthen community-based prevention and response initiatives and with development partners to seek out funding for GBV services. Further, there should be a deliberate effort to ensure annual allocations for GBV prevention and response from the County Government subsequent Years on GBV.

#### **Department Response**

The departmental work plan for FY 2024/2025 was submitted; Kshs. 1,000,000 had been allocated for awareness on GBV and Kshs. 500,000 for GBV recovery centre programmes for SGBV survivors.

### **Committee observation**

More resources should be allocated to the department for GBV to be adequately budgeted.

### **Resolution 2**

**THAT**, the department of Gender and Culture fast-tracks the submissions to the County Assembly within 90 days from the adoption of this report the following legislations;

- a) Sex and Gender- Based Violence Bill, 2019
- b) Gender Mainstreaming policy

### **Department Response**

The Sex and Gender - Based Violence Bill, 2019 and Gender Mainstreaming Policy were submitted to the County Assembly but only the Gender Mainstreaming Policy has been approved by the County Assembly.

### **Committee observation**

The Gender Mainstreaming Policy was approved but the Sex and Gender Based Violence Bill, 2019 had not been submitted. A copy of the legislative proposal was submitted to the committee during the interrogation.

### **Resolution 3**

**THAT**, to effectively address multiple and cross-cutting issues related to GBV, it is important that all the relevant players participate fully in the process. There is need to strengthen collaboration and accountability within both state and non-state actors to access holistic survivor-centered response services and effective prevention programs.

### **Department Response**

A gender sector working group is in place which is a multi-sectorial formation drawing members from state and non-state actors and Kenya-Finland Bilateral programme on Gender Based Violence was implemented in the County.

### **Committee Observation**

The Kenya Finland Bilateral programme booklet was submitted to the committee that showed the GBV duty bearer for the 45 wards.

### **Resolution 4**

**THAT**, the department should create community awareness on FGM, early marriage, physical violence, sexual violence, other forms of GBV and the law

### **Department Response**

The department submitted that it had undertaken the following;

- Trainings on positive parenting yielded reduced numbers in teenage pregnancies

Other than the Gender mainstreaming policy that was approved by the House, evidence to confirm that the other activities were implemented was not submitted to the Committee.

### **Resolution 5**

**THAT**, the department of Gender and Culture in collaboration with the department of Health should establish facilities and infrastructure to deliver GBV prevention and response services such as GBV recovery centers, forensic labs, gender desk in every public hospital and safe shelters

### **Department Response**

The resolution has not been submitted due to;

- Frequent transfers of trained police officers
- No forensic labs established
- GBV forensic science is expensive
- Lack of enough manpower to manage GBV desks in public hospitals
- No safe houses
- No goodwill to unlock the politics surrounding the Ndengelwa GBV centre

### **Committee Observation**

The resolution has not been implemented

### **Resolution 6**

**THAT**, the department should set up a toll free number that would support calls and SMS for the residents. Further sensitization is required on the importance and proper usage of the line.

### **Department Response**

A GBV toll free number 0800724651 had been established in the county sponsored by the partner who withdrew and switched off the line.

### **Committee Observation**

There is no toll free number

### **Resolution 7**

**THAT**, the department of Gender and Culture should be involved in a series of sensitization activities and outreach within the 45 wards, using various platforms including door to door sensitization, through gender sector working groups and use of local radio stations.

**Department Response**

The Kenya Finland Bilateral program supported intensive sensitization, GSWG involvement on GBV prevention and response was done in all the 45 wards.

**Committee observation**

The list of duty bearers and rights holders used for GBV prevention and response services across the 45 wards in the Kenya- Finland Bilateral program was submitted. But the lapse of the bilateral programme hugely affected sensitization in the county because the department has no budget to match up.

**Resolution 8**

**THAT**, duty bearers should be better resourced and frequently trained on GBV so that they can detect and handle both child and adult cases appropriately and effectively in their line of duty.

**Department Response**

The department submitted that Police officers, health workers, gender officers and teachers were trained.

**Committee observation**

Evidence for the trainings was not provided.

**Report on Bungoma County Government Nine Months Financial Statements for FY 2022/23 with Respect to the Department of Gender and Culture**

**Resolution 1**

**THAT**, the County Treasury should indicate how much each department received as exchequer for easy comparison in the three quarters.

**Department Response**

The department submits to the treasury the total funds it received and how it was spent but treasury does not indicate it in the consolidated report.

**Committee observations**

During the interrogations of the quarterly financial statements and reports, the department usually avail to the committee the funds it received in the quarter and how it was spent.

**Resolution 2**

**THAT**, the department should submit departmental monthly/annual work plan and budget implementation reports for comparison purposes with the financial report by the committee

The departmental work plans should be submitted to the committee at the beginning of the financial year and the budget implementation reports at the end of each quarter for effective oversight.

### **Resolution 3**

**THAT**, the department should report expenditure for Gender, Culture, Youth and Sports separately to ease scrutiny by the committee.

### **Department Response**

Expenditure reports for Gender and Culture has been prepared separately from Youths and Sports, a copy was share but the County Treasury while consolidating, it combines with the one for Youth and Sports.

### **Committee observation**

During interrogation, the department submits its expenditure that does not include that of youth and sports.

### **Resolution 4**

**THAT**, the department should give pending bills first charge during budgeting.

### **Department Response**

Pending Bills are not fully budgeted for.

### **Committee observation**

The pending bills are not given first charge during budgeting.

## **Report on the assessment of application of laws guiding the implementation of programmes by the department of Gender and Culture**

### **Resolution 1**

**THAT**, the department should ensure that the directorate of Liquor licensing is fully operational in compliance with section 4 of the Bungoma County Drinks Control Act, 2015.

### **Department Response**

The Directorate was established under the County Public Service. The directorate operates as a county committee of 12members but the director has not been appointed by the County Public Service Board.

The directorate is in place but a substantive director has not been appointed.

**Resolution 2**

**THAT**, the directorate once fully operational must ensure that the ACT is fully implemented including the development of subsidiary legislations referred to under sections 10 and 74 of the Bungoma County Alcoholic Drinks Control Act, 2015.

**Department Response**

The Bungoma county Alcoholic drinks regulations were formulated and are awaiting endorsement by the county assembly and gazettlement for complete operationalization. A copy of the regulations was submitted to the committee.

**Committee observations**

The Regulations have not been formally tabled in the County Assembly.

**Resolution 3**

**THAT**, the department should ensure budgetary allocation for sub-county Liquor licensing committees in the subsequent budgets.

**Department Response**

In the 1<sup>st</sup> Supplementary FY 2024/2025, funds were allocated to operationalize the sub county liquor licensing committees.

**Committee observation**

There is need to enhance the allocation for liquor licensing committees.

**Resolution 4**

**THAT**, the department should fast track the submission of the draft policies on child protection, Cultural heritage and protection, Gender mainstreaming and Disability mainstreaming to the County Assembly for processing and approval within 60 days from the approval of this report.

**Department Response**

The Policies were submitted and considered by the House.

**Committee observation**

The policies were approved and should be operationalized.

**Resolution 5**

**THAT**, the department should use the legal and policy frameworks in implementing its programmes. E.g. recognizing heroes and heroines in the County in order to ensure transparency, openness, accountability and prudent use of public funds/resources

The department has fully applied the existing legislation in implementing its programmes and the Bungoma County cultural heritage Act, 2023 is in place to guide in the recognition of the heroes and heroines.

Regulations are required to fully operationalize the Bungoma County Cultural Heritage Act, 2023

**The Bungoma County Alcoholic Drinks Control Act, 2015****Department Response**

The Act has partially been operationalized;

- Alcoholic Drink Control Directorate is in place but the director has not been employed
- Rehabilitation facilities and programmes not put in place
- Alcoholic Drink fund not established
- Control of alcoholic drink has been done partially
- Sub-county committees established but the department is not able to currently absorb funds for operationalization of the sub county committees due to a mandatory advisory by COB to gazette committees before drawing any allowances.
- Minimal Budget has been allocated to fully implementing the Act.
- Revenue is collected by the Finance department
- The department has not initiated the review of the Act

**Committee observation**

The department has never submitted any report on the implementation of the Act and to fully operationalize it, the Regulations should also be fast tracked.

**The Bungoma County Cultural Heritage Act, 2023****Department Response**

The Act was gazetted and fully operational in the implementation of the following programmes;

- Construction of phase two of the Sang'alo multipurpose cultural hall at the Sang'alo Cultural Centre
- Training of cultural circumcisers for safe cutting of the initiates
- Embalu partnership between Bamasaaba Uganda chapter and Kenya chapter
- Sensitization forum with cultural practitioners and awareness creation on cultural values.

**Committee observation**

The department did not demonstrate how the Act has affected the implementation of the above activities.

**The Bungoma County Public Entertainment Act, 2023****Department Response**

It is in the process of harmonizing the public amenities in the County and due to budget constraint it has not implemented the Act.

**Committee observation**

The Act has not been implemented.

**COMMITTEE OBSERVATIONS**

The Committee observed the following:

1. The budgetary allocation to the Department of Gender and Culture remains inadequate to effectively implement its core programs in line with its mandate, sustain donor-initiated interventions and fully operationalize the legislations enacted under its purview.
2. The department submitted to the Committee that the Sexual and Gender-Based Violence Bill 2019, the Bungoma County Alcoholic Drinks Control Regulations, and the amended Bungoma County Women and Disability Fund Regulations had been forwarded to the County Assembly. However, the referenced documents are not in the County Assembly and the department could not avail copies of the documents.
3. When the Department claims to have implemented a majority of the resolutions previously adopted by the House, it did not provide adequate documentary evidence to substantiate these claims. Most of the submissions presented were unverified, casting doubt on the actual scope and effectiveness of the reported implementation.
4. The Department submitted its financial year 2024/2025 work plans across all directorates, reflecting an effort towards forward planning. However, the absence of the corresponding budget implementation report impedes the Committee's ability to evaluate consistency between planning and the actual execution. Furthermore, the continued consolidation of expenditure reports by the County Treasury hampers transparency and limits programme specific accountability.
5. The Department has not undertaken any efforts to review or amend the Bungoma County

Alcoholic Control Act 2015 despite significant shift in the county's economic and social context. Considering that the Act serves as a legal basis for revenue collection. Its continued implementation without revision raises valid concerns regarding its relevance, effectiveness and alignment with current realities.

## **COMMITTEE RECOMMENDATIONS**

The Committee recommends the following;

1. THAT, the County Executive Committee CEC prioritizes increasing budgetary allocations to the Department of Gender and Culture. This will ensure the effective implementation of Departmental mandates, sustainability of donor initiated interventions and the full operationalization of enacted legislation pursuant to article 203 (1)(a)(b) of the constitution of Kenya 2010, which supports equitable resource allocation and the need to address marginalization.
2. THAT, the Department should submit to the County Assembly the sexual and Gender-Based Violence Bill, The Bungoma County Alcoholic Drinks Control Regulations and the amended Women and Disability Fund Regulations 30 days from the adoption of this report. This will facilitate timely legislative review in accordance with article 185 (1) of the constitution. The Department is further advised to develop an internal tracking mechanism for legislative submissions to enhance legislative efficiency.
3. THAT, the Department should ensure the submission of verifiable reports supported by adequate documentation on all the reports adopted by the County Assembly within 60 days from the adoption of this report as per the provision of Standing Order no. 205 (2).
4. THAT, the Department should be submitting the annual work plans within 30 days after the approval of the annual budget estimates and quarterly and annual budget implementation reports in compliance with section 166 (4) part a of the PFM Act 2015. The Committee also recommends that the County Treasuries separate expenditure reports to reflect specific allocations and spending per department to enhance program-specific accountability and transparency.
5. THAT, the Department should initiate comprehensive review and amendment of the Bungoma County Alcoholic Drinks Control Act 2015 30 days from the adoption of this report taking into account the evolving socio-economic changes in the county. The review process should be guided by Section 5(2) of the County Governments Act 2012, which mandates periodic evaluation of County Legislation for relevance.
6. Finally, the Department should implement all the Committee recommendations illustrated herein and within the timeline stipulated, in case of any failure the Committee shall issue sermons pursuant to Standing Order (254) of the County Assembly of Bungoma and Article( 195) part 1 of the Constitution of Kenya 2010.

**Mr. Speaker:** Hon. Ken, proceed.

**Hon. Ken Wanyama:** Thank you, Honourable Speaker. I rise to second the report on the status of House resolutions from the Committee on Gender Culture and Social Welfare. Year in year out, we have experienced inadequate Budgetary allocation to this Department which has actually affected delivery of services. This is a very key Department because it is department that is actually dealing with the most vulnerable in the society that is women and persons living with disability.

This Department also deals with the issue of Culture and what is discouraging is that from our interrogation with the Department is that despite the Department preparing and submitting work plans that includes this programs, but usually when it gets to the Cabinet level somehow the same are actually removed, so I just want to urge the Executive to be more serious with this Department so that it can be able to discharge its mandate.

We have various bills and regulations that are pending in this Department; the first one is Sexual and Gender based Violence Bill 2019. Mr. Speaker, as you may be aware Bungoma County was actually voted amongst Counties with the highest cases of Gender based Violence, so the Department needs to fast-track this bill so that issues of GBV can be dealt with appropriately.

The second regulation; is Alcoholic Drinks and control regulations, the Directorate on the Liquor Licensing, that despite the Department trying to have even Ward Committees at the ward level to carry out these functions, the same team is not facilitated at all. There is no budgetary allocation for them. It is even worse because there is no Director for that section of the Department and this is despite the Department making several requests to the Public Service Board, there is no positive results. The Public Service Board should fast-track appointment of the Director of Liquor Licensing so that the Directorate can be fully operational.

Thirdly, we have the Women and Disability Fund regulation; we have previously witnessed Budgetary allocation towards Women and Disability Fund but the same has always been reallocated and the reason being that we do not have regulations in place, so we urge the Executive to fast-track so that in the coming Financial years Women and other vulnerable people in society can also have a budget to run their programs.

We have also witnessed a scenario where the County Treasury while reporting expenditure is actually consolidating the expenditures for the Department of Gender and the Department of Youth and Sports and for accountability, we need to have the expenditures reported separately, that will enable the committee to scrutinize the expenditure and a case in example is pending bills for this department. When you look at the figures reported for this department, and what is

reported as pending bills for the department of Youth and Sports, and you compare the same with what the Treasury is reporting. They actually do not reconcile and so for accountability we urge the County treasury to separate this expenditure reports so that as a committee, we can be able to do proper oversight.

On the issue of oversight in regard to work plans; we have recommended that the department should submit work plans 30 days after approval of the annual budget estimates. If work plans are submitted early, then it will enable us as a committee to be able to do budget tracking and give the needed guidance and advise so that expenditures are actually done within the approved budgets.

Lastly, this is in regard to the review and operationalization of the Alcoholic Drinks Control Act 2015. The department has not actually operationalized this Act despite this Act being very key in terms of even assisting the County increase the own source revenue. In the last financial year 2024/2025 as a committee, we pushed and appropriated Kshs.5million towards this function. So we are waiting for the department, they have told us by 31<sup>st</sup> of August this year, they will have operationalized this Act, so that then it can enable the department to collect revenue from the alcoholic drinks. I second.
