## QUESTIONS AND STATEMENTS

### RESPONSE TO A STATEMENT RAISED BY HON JEREMIAH KULOBA THE CHAIRPERSON, SECTORAL COMMITTEE OF LANDS, URBAN, PHYSICAL PLANNING AND HOUSING

**Mr Speaker:** Yes, let me start by confirming the owner of the statement Hon. Jeremiah. He's present. Hon. Ipara, proceed.

**Hon. Johnston Ipara:** Hon. Speaker Sir, I have a progress report by the Committee on Lands, Urban, Physical Planning and Housing on a statement raised in this House by Hon. Jeremiah Kuloba.

The Committee on Lands, Urban, Physical Planning and Housing received a question sought by Hon. Jeremiah Kuloba in this House on 25<sup>th</sup> June, 2025 and referred to Committee for answers.

Pursuant to Standing Order 47(2) (C) of the Bungoma County Assembly Standing Orders, The committee was given up to the 9<sup>th</sup> of July 2025 to provide a reply through the Chairperson.

The committee on 26<sup>th</sup> June, 2025 through the Office of the Clerk wrote a letter to the CECM Lands, Urban, Physical Planning and Municipalities inquiring reply to the statement raised. The reply was to reach the Office of the Clerk of the County Assembly and consequently to the Committee on 3<sup>rd</sup> July, 2025 and the CECM was required to appear before the committee on 7<sup>th</sup> July, 2025.

However, the CECM was stuck in Nairobi due to the recent *Saba Saba* protests and could not attend the meeting. The committee has therefore given a copy of the reply to the owner of the statement and rescheduled the meeting with the CECM to Thursday 10<sup>th</sup> July, 2025.

The committee therefore asks leave of the Honorable Speaker and the House to allow it interrogate the CECM in the presence of the owner of the statement and report back to the House. I beg to report.

**Mr. Speaker:** Hon Jeremiah, you heard what they are saying. They do have the response and you have the response. They are seeking that you appear tomorrow before the committee alongside the CECM of the said committee.

**Hon. Jeremiah Kuloba:** Thank you, Mr Speaker. I agree with what the committee has given. I will appear there and they give me verbal response and written responses.

**Mr. Speaker:** It's okay. Kindly be there so that we have a feedback thereafter. Yes, Hon Majority Leader.

**Hon. Joseph Nyongesa:** Thank you, Mr Speaker. Though as much as maybe the owner of the statement is agreeing with the statement from the Education Committee, I'm concerned about the issue that the CECM was stuck in Nairobi because of *Saba Saba*. And you are aware during the signing of the budget that we approved in this House, we were with the CECM on Monday. So how was she stuck in Nairobi and yet we were with her, so the committee should also make a follow-up so that we should not be cheated. We are a House of Rules and Procedures.

**Mr. Speaker:** Hon. Majority Leader, was the CECM of Lands present? He was not present.

**Hon. Joseph Nyongesa:** Anyway, I withdraw my statement. But again an office is not part of the CECM, because when the statement was raised, was the *Saba Saba* on? They were given 14 days. So that excuse also won't work.

**Mr. Speaker:** Now they have sought for tomorrow which is not far. Equally there was a statement raised by the Committee on Education. When we adjourned yesterday, I got the response on my table. So I think what Hon. Allan was saying, it's becoming a habit in that Committee. Let all of them be handled together.
