**NOW THEREFORE**, this Assembly **RESOLVES** to alter its Calendar for the year 2025 by converting the period between Friday, 31st October 2025 and Monday, 10th November 2025 into a sitting week, making the 4<sup>th</sup> , 5<sup>th</sup> , and 6<sup>th</sup> days of November 2025 sitting days, thereby suspending the previously scheduled recess.
