COMMUNICATION FROM THE CHAIR

Hon. Speaker: Honourable members, I have two communications to make. The first one is touching on our honorable member's welfare. The Bungoma County 1st Supplementary Appropriation Bill, 2022

Hon. Speaker: Honourable members, the bill having been read for a third reading in compliance with section 24 of the County Government Act.
